CHANGE OF COMPANY NAME AND STOCK SHORT NAME

References are made to (i) the announcement of China Wacan Group Company Limited (the “**Company**”) dated 1 April 2026; (ii) the circular of the Company dated 14 April 2026 (the “**Circular**”), in relation to, among other things, the Proposed Change of Company Name; and (iii) the announcement of the Company dated 29 April 2026, in relation to the poll results of the extraordinary general meeting held on 29 April 2026 (the “**EGM**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Circular.

CHANGE OF COMPANY NAME

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that subsequent to the approval of the special resolution at the EGM, approving the English name of the Company to be changed from “China Wacan Group Company Limited” to “Junwea Group (China) Company Limited” and the Chinese name of the Company from “中國網成集團股份有限公司” to “巨美集團(中國)股份有限公司” (the “**Change of Company Name**”), by the shareholders of the Company (the “**Shareholders**”), the Certificate of Incorporate on Change of Name was issued by the Registrar of Companies of the Cayman Islands on 6 May 2026.

The Registrar of Companies in Hong Kong issued the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company on 22 May 2026, confirming the registration of the Company’s new English and Chinese names in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

With effect from 9:00 am on 3 June 2026, the stock short name will be changed from “CHINA WACAN” to “JUNWEA GROUP” in English and from “中國網成” to “巨美集團” in Chinese for the purpose of trading in the shares of the Company (the “**Shares**”) on the Stock Exchange. The stock code of the Company on the Stock Exchange will remain unchanged as “1920”.

EFFECT OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company will continue to be evidence of valid title and valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the exchange of the existing share certificates for new share certificates bearing the new name of the Company. Thereafter, the new share certificates of the Company will be issued under the new name of the Company.

The Change of Company Name will also not affect the daily business operations and financial position of the Group.
